1. **Establishing Time and Place of Meeting. (O.R.C. 3313.15).** Establish the regular monthly meeting of the Franklin Monroe Local School District Board of Education to be held on the third Monday of each month at 8:00 p.m. in the conference room, unless otherwise specified: February 27, 2017, June 26, 2017 and August 14, 2017.
2. **Compensation of Board Members.** Approve compensation for serving on Franklin Monroe Board of Education including attendance of a meeting or meetings each month shall be for a maximum of thirteen meetings per year. Compensation as per board adopted policy.
3. **Service Fund (O.R.C. 3315.15).** To establish a service fund for the Franklin Monroe Board of Education, as per appropriation resolution.
4. **Adoption of Existing Board of Education Policies.** To adopt existing Franklin Monroe Board of Education policies as legislative direction for the operation of the Franklin Monroe Local School District.
5. **Membership in Ohio School Boards Association.** To renew membership in the Ohio School Boards Association.
6. **Purchase from Ohio Industries for the Handicapped (OIH).** To declare not to purchase from Ohio Industrial for the Handicapped (OIH) during calendar year 2017 due to noncompetitive pricing.
7. **Legal Services:** Maintain using Janet K. Cooper with Bricker and Eckler LLP as the school district's legal counsel during the calendar year 2017.

3. **Investment Fund.** To authorize the treasurer to invest active/interim/inactive funds at the most productive interest rates whenever funds are available.

- 1. Appointment of Purchasing Agent.** The superintendent is hereby given authority to act as purchasing agent and fiscal agent for participation in local, state, and federal projects for the school district for calendar year 2016. Such appointment authorizes purchases and payment of invoices subject to the limitations of the appropriations resolution(s). Such authorization includes the approval for employees (including self) to attend meetings and the payment of the expenses subject to the limitations of the annual appropriations resolution(s). The Franklin Monroe Board of Education reserves the privilege of approving trips, which will be out of state.
- 2. Employment of Temporary Personnel.** To authorize the superintendent to employ such temporary personnel, as needed, for emergency situations. Such employment shall be presented for approval by the board at the next regularly scheduled board of education meeting.
- 3. Accept Resignations.** To authorize the superintendent, on behalf of the board, to accept resignations which have been submitted by employees during times when the board is not in session, subject to ratification by the board; provided however, that upon ratification by the board, such resignations shall be deemed effective as of the date and time of the superintendents acceptance.
- 4. Temporary Paid Administrative Leave.** To authorize the superintendent to place employees on Temporary Paid Administrative Leave until the board of education can take further action if needed.
