Mrs. Wolf moved and Ms. Brumbaugh seconded a motion that the Superintendent recommends approving the following resolution:

RESOLUTION DETERMING TO PROCEED WITH THE PROPOSITION OF AN INCOME TAX (Ohio Revised Code Sections 5748.02 and 5748.03)

WHEREAS, the Board at its meeting on December 21, 2020 determined that it is necessary to raise annually revenues of at least \$417,594 for the purpose of providing for current expenses for the School District; and

WHEREAS, the Tax Commissioner of the State of Ohio has estimated and certified the property tax rate and the income tax rate required in order to produce such revenues; and

WHEREAS, the income tax rate, rounded to the nearest one-fourth of one percent as required by law, is 0.50% per annum;

NOW, THEREFORE, BE IT RESOVED by the Board of Education of the Franklin-Monroe Local School District, Darke and Miami Counties, Ohio, a majority of the members of the Board concurring, that:

<u>Section 1.</u> It is hereby determined to be necessary to proceed with the proposition of levying an income tax (the "Income Tax") on the school district income of individuals and estates resident in the School District. Such income tax shall be at the rate of 0.50% per annum, shall be for the purpose of providing for current expenses for the School District, shall take effect and begin to be levied on January 1, 2022, and shall be levied for a continued period of time.

<u>Section 2.</u> The income that shall be subject to the Income Tax is the taxable income of individuals and estates as defined in Ohio Revised Code Sections 5748.01(E)(1)(a) and (2).

<u>Section 3.</u> The question of levying the Income Tax shall be submitted to the electors of the School District at the election to be held at the usual voting places within the School District on May 4, 2021.

<u>Section 4.</u> The form of the ballot to be used at said election shall be as follows: Shall an annual income tax of one-half percent (0.50%) on the school district income of individuals and of estates be imposed by the Franklin-Monroe Local School District for a continuing period of time, beginning January 1, 2022, for the purpose of providing for current expenses for the School District?

<u>Section 5.</u> The Treasurer of the School District is hereby directed to certify a copy of this Resolution to the Board of Elections of Darke County, Ohio, no later than February 3, 2021.

<u>Section 6.</u> It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Ohio Revised Code Section 121.22.
